Methods: The data presented in this fact sheet were collected as part of the California Healthy Kids Survey in the 2015-2017 academic years at middle and high schools across Lassen, Modoc, Plumas, Sierra and Siskiyou counties. The data were collected using a paper and pencil survey or online survey administered by school sites and reported to and compiled by WestEd. Kris De Pedro, Ph.D. at Chapman University, the ACLU of California, and John Elfers at Sofia University requested the dataset from WestEd. The data were analyzed running Chi-Square tests using SPSS statistical software. All differences reported here are statistically significant. The California Healthy Kids Survey was developed by WestEd under contract to the California Department of Education. This fact sheet was prepared by Kris DePedro, PhD and John Elfers, PhD in collaboration the American Civil Liberties Union (ACLU) of California.
