Methods: The data presented in this fact sheet were collected as part of the California Healthy Kids Survey in the 2015-2016 academic year at middle and high schools across Riverside County. The data were collected using a paper and pencil survey administered by school sites and reported to and compiled by WestEd. Kris De Pedro, Ph.D. at Chapman University, the ACLU of California, and John Elfers, PhD. at the Central Coast Coalition for Inclusive Schools requested the dataset from WestEd. The data were analyzed running Chi-Square tests using SPSS statistical software. All differences reported here are statistically significant. The California Healthy Kids Survey was developed by WestEd under contract to the California Department of Education.
